Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do. |
| <b>What?</b> | The types of personal information we collect, and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>• Social Security number and income</li> <li>• Account balances and payment history</li> </ul>                                   |
| <b>How?</b>  | All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons we choose to share; and whether you can limit this sharing.                     |

| <p><b>Affiliates</b></p>      | <p>Companies related by common ownership or control. They can be financial and non-financial companies.</p>                      |
| <p><b>Non-affiliates</b></p>  | <p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p>                   |
| <p><b>Joint marketing</b></p> | <p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p> |
